An Inspection team was constituted vide notification No. MZU/CDC-1/43/25/3249; Dated 22nd May, 2025 with Prof. G. Gurusubramanian, Dean, School of Life Sciences, Mizoram University as a convener. The team visited the college on 27th May 2025(Tuesday) at 2:00 pm.

RECOMMENDATIONS:

Based on the observation and recommendation of the inspection team, the affiliation committee recommends that- Permission may be granted for renewal of Provisional Affiliation for **2 years** w.e.f 2025 – 2026

The following conditions may be fulfilled before next inspection

- 1) Promotion amongst eligible Assistant Professor to Associate Professor and Professor should be considered by the management as per INC rules and regulations. This service rules may be met by the competent authority. Filling up of Associate Professor and Professor should be pre-requisition for seeking permanent affiliation.
- 2) To create non-functional career advancement scale between Assistant Professor and Associate Professor as per UGC norms.
- 3) Librarian promotion should be the same as prescribed for College faculty under Career Advancement Scheme (CAS)/ UGC regulations, 2018.
- 4) NAAC accreditation process should be planned and initiated and speeding up of Accreditation process.
